

- 1. The Headmaster Rev. Dushantha Rodrigo, led the House in Prayer prior to the commencement of the Meeting. Thereafter the 35th Annual General Meeting of the S. Thomas' Preparatory School Old Boys'Union (OBU) was called to order by the Headmaster, who presided over the Meeting. The Notice convening the 35th Annual General Meeting of the OBU had been published in the Daily Mirror and the web-site of the OBU www.prepobu.ik and was taken as read.
- 2. No Excuses were received.
- Two Minutes Silence was observed in remembrance of Old Boys who have passed away since the last Annual General Meeting held on 5th June, 2015.
- 4. The Headmaster, Rev. Dushantha Rodrigo, the Ex-Officio President of the OBU addressed the Meeting. Given below are extracts of his address:-

It is my second AGM and my encounter with you has been a rewarding one. The field of education has seen many changes and many more are in the offing. But we are here with memories of the past and want to live through some of those very events that thrilled us that brought embarrassment or shock to a teacher or a fellow Prepite.

In your hands this evening is a report of the work done by the OBU and you will be able to read at leisure the work that has been done.

I am also in debt to the many class groups or batches that have been walking along with the School taking on many projects and seeing it completed and sometimes getting involved in setting it up themselves. The Batch of 98 came forward to install purified drinking water for the boys and their second project is already in progress. The Class of 79 contributed over a Million Rupees towards the Basketball Court is and getting ready to donate an interactive Smart Projector to the School. The class of 2001 has embarked on gifting a Computer lab to the School. The Staff Resource Center is another gift to the School that was sponsored by Mr. Christian Fernando and his batch mates. The ceiling fans to all class rooms were given by a batch who took the initiative and got others to contribute as well.

Prep School is getting smaller. The Marine Drive will be through the School and many of you might arrive for the next AGM from the Marine Drive.

Swimming Pool: A long felt need is a Swimming pool which is now being designed for the School: I thank Mr. Nihal Ferdinado who has volunteered to do the design and advise us on the structure.

Grounds: The School is still in the negotiating process with the Zonal Department of Education to obtain a ground for the School. A ground has been identified, but it has run into certain problems which have to be sorted out.

Table Tennis; We have once again revived Table Tennis and the OBU gifted the School with a table-tennis table.

Rugger. Gehan Dias and a few Prepites have been actively involved in the last few weeks in helping out with the coaching.

Melbourne Prep. OBU: Mr. V Nesiah ras sent funds for the Scholarships.

"Fortrose" Building & Prep. Walk & Fun Fair 2017. Our oldest building needs aftention and care and the engineer has submitted a report to the effect that that the perimeter walls are in bad state of repair and we envisage the repair to cost over 100 Million Rupees. The Parent Teacher Association of the School and the OBU have come together to raise funds for the above building through a Walk and Fun Fair.

In Conclusion, I invite you to journey with the School in meeting the various needs and enabling us to be with an educational institution of a very high caliber.

- 5. The Minutes of the 34th Annual General Meeting held on 5th June, 2015 were circulated and proposed and seconded respectively by Mr. Siri Perera and Mr. Glen Nugawela and duly adopted.
- 6. Arising from the Minutes Mr. Janaprith Fernando queried about what action had been taken with regard to the OBU Trust Fund. Mr. Rajindh Perera, a Sub-Committee Member appointed by the Executive Committee to looked into the OBU Trust Fund stated as follows in response: "The work of the Sub-Committee appointed to clarify matters on the OBU Trust was initially slow as information and documentation relating to the Trust Fund

was not readily available. However, we have managed to find the necessary documentation, some of it very recently, and I am happy to inform the House that the Trust Fund monies have been traced and are placed in the following accounts/investments: a.) Current Account at Commercial Bank for Rs. 3,210,943.41/=; and b.) Investment at First Capital Treasuries PLC for Rs. 3,021,406.33. The Trustees of the OBU Trust Fund according to the Trust Deed are the Headmaster, the Secretary and Treasurer of the OBU, and 2 persons nominated by the Headmaster. Currently, there were two vacancies as the two nominees of the Headmaster had resigned. As the Trust Deed provides for three Trustees to act it will be up to the new Trustees after this AGM to consider its future investment plans for the OBU Trust Fund. The School had also located the past audited accounts of the OBU Trust Fund and the Sub-Committee was of the view that a full audit of the Trust Fund should be carried out.

- 7. The Acting Secretary, Mr. Kishan de Silva, stated that the Annual Report of the activities of the OBU for the period: 2015/2016 had been circulated. The Annual Report was duly adopted by the Flouse, pursuant to being proposed and seconded by Mr. Siri Perera and Mr. Glen Nugawela respectively.
- 8. The Treasurer, Mr. Haroun Cader, stated that the audited Statement of Accounts for the financial period 1st July 2015 to 31st March 2016 had been circulated. The audited Statement of Accounts for the financial period 1st July 2015 to 31st March 2016 was adopted proposed by Mr. Imran Hassan and seconded by Mr. Sujeeva Fernando and duly adopted
- 9. The Resolution to amend the Rules of the S. Thomas, Preparatory School Old Boys Union was circulated and was duly passed unanimously.



Further, since the Headmaster had received five nominations for the three positions of Vice Presidents of the OBU an Election was called and conducted by the Auditor's of the OBU, SJMS Associates. The results of the Election for the three (3) Post of Vice Presidents were declared by the Headmaster after the result was certified by the SJMS Associates and were as follows: 1. Mr. Kesara Serasinghe - 64 Votes, 2. Mr. Naresh Ediriwira - 59 Votes, 3. Mr. Nilantha Fernando - 58 Votes, 4. Dr. Dilan Illapperuma - 21 Votes and 5. Mr. Chrismal Warnasuriya - 14 Votes. Accordingly, Mr. Kesara Serasinghe, Mr. Naresh Ediriwira and Mr. Nilantha Fernando were declared duly elected as the Vice Presidents of the OBU for the Year: 2016/2017.

Two Old Boys, Mr. R.C. Gulasekharam and Mr. G.S.K. Nugara, informed the House that they would like the OBU to post the AGM Notice in the future, as they did not have e-mail nor read the Newspaper.

- 13. After the items listed in the Agenda were concluded, the proceedings of the 35th Annual General Meeting of the OBU were terminated by the Headinaster, pursuant to the singing of the School Song.



It is my pleasure, as Secretary, to submit the Annual Report on behalf of the Executive Committee for the year 2016/2017.

It is with great satisfaction that I state, without any hesitation, that the S. Thomas' Preparatory School Old Boys' Union (OBU) has come a long way since the last Annual General Meeting (AGM) and that I am proud of the significant contribution the OBU has made towards the development of our beloved school.

The School's flagship project, The Prep Walk & Fun Fair was a manmoth project that involved organizing the first ever Walk by the School and a Fun Fair at the School premises after the lapse of many years, all with a view to raising funds to preserve the humble beginnings of the School - the Fortrois building, where our Founder, W. T. Keble, gave life to his vision for modern education. I am grateful to the Headmaster for inviting the OBU to play a part in this project. While the Walk and Fun Fair raised the much-needed funds for the School and breathed a new sense of life to the School premises it also provided an opportunity for Old Boys to reconnect with the School and many of them have thereafter, continued to work, either individually or as batches, towards the development of the School. The aim of the Walk was to equip the School to face the future, but it also provided the Old Boys with an opportunity to walk down "Memory Lane". I take this opportunity to place on record my sincers appreciation of the role played by Mr. Hiran D. Molligoda, the Hony Assistant Secretary of the OBU who was Chairman of the project. He was an able, meticulous and resourceful leader who showed us that with grit and determination nothing is impossible Linust also make special mention of Mr. Fayyaz Mukthar, a Member of Executive Committee, who worked tirelessly towards making this project the success that it was. The Frep Walk & Fun Fair was a remarkable success and I thank Hiran and the team!

Prep Night 2017 - the Dinner Dance of the OBL, the main fundraiser for the year, was also held very successfully under the able leadership given by Mr. Imran Hassan, the Project Chairman. The Prep Night dinner dances have only got better each year and due to repeated requests for such social events we hope to ensure that it is held regularly. I thank Imran and his team of Old Boys for their untiring efforts, dedication and commitment towards the project which raised a record income.

The funds raised from the Prep Night 2017 will be utilized for the "Baby Elephant Bath" - the project to construct a swimming pool for the School for which the Executive Committee has made an initial pledge of a stim of Rupees 5 million to the Headmaster. As you may already know a part of the School grounds will be lost due to the Marine Drive Extension depriving the students of the little space they had to enjoy outdoor activities. Thus, the School identified the construction of a pool as a vital necessity to ensure that the present generation of students are not deprived of the opportunity of enjoying outdoor activities and the Vice President of the OBU, Mr. Kesara Serasinghe, has been spearheading this project. I am pleased to inform you that on the 17th of May, 2017 the foundation stone for the pool was laid by the Bishop of Colombo, Rt. Revd. Dhiloraj Canagasabey, at a ceremony held in conjunction with the Founder's Day celebrations. I thank Kesara for his single-minded determination in ensuring that this dream becomes a reality.

The construction of the pool in only one of many infrastructure developments envisaged for the School. The Headmaster is at present working with architects, engineers and other experts to draw up a master plan for the school. Towards this end, with our active participation in

infrastructure development committee meetings at the invitation of the Headmaster, we are confident that the plans he has for this school will bear fruit, slowly but steadily.

The cost of constructing the pool in a manner in which the School can make maximum utility of the limited space it has, will cost a significant sum of money while the envisaged infrastructure development of the School will cost much more. I consider it imperative that the OBU works closely with the Headmaster in these efforts so that our efforts are focused and synergized and I look forward to the continued support of the Members of the OBU towards achieving these goals.

Due to the two large scale projects undertaken by the OBU some of the other projects we had planned for during the year could not be implemented. However, the OBU has continued to assist the School in many ways, whenever it has been called upon to do so.

I am happy to report that the sub-committees of the OBU which handle the administrative matters of the OBU have functioned smoothly. I am extremely pleased with the progress made by the Membership Development Sub-Committee which has cleared a backlog in processing applications for membership and updated the membership database. The Web & IT Sub-Committee has also worked irelessly to disseminate information of our activities both on the web-site and on Facebook. In the past, we have faced many difficulties in disseminating information about the activities of the OBU and I am pleased that the work of these two committees have addressed this issue to a great extent. The newly formed Legal and Constitutional Affairs Sub-Committee is studying the Rules of the OBU and the Trust Deed of the OBU Trust Fund with a view to amending them. I am happy to report to you that all the monies of the OBU Trust Fund have now been invested in interest bearing accounts/investments.

I must first thank the Headmaster and our ex officer President, Revd. Dushantha Rodrigo, not only for the manner in which he has engaged with the OBU but also for his futuristic vision for the School which has given the OBU a sense of direction and purpose. Much of what the OBU has achieved this past year is due to his enthusiasm and unstinted cooperation and support. He has also never failed to include the OBU in the activities of the School.

I also thank the Members of the Board of Governors with whom we interacted with when carrying out our large scale projects for the School for their continued support of the OBU.

Although we have not had a Staff Coordinator over the past year we have hardly felt it due to the unstinted support we have received for the academic and administrative staff of the School. In fact, the Prep Walk and Fun Fair would not have become a reality if not for the support from the staff. I would like to thank the clerical staff who assists us in conducting our meetings. In organizing the Prep Walk and Fun Fair we also, for the first time, worked with the Parent Teacher Association (PTA) of the School and I thank the office bearers of the PTA for their cooperation.

I would fail in my duty if I did not recognize the service rendered to the School by the many Batch/Class groups who have carried out many projects on their own. We look forward to such initiatives as well as closer interactions with such groups in order to harmonize our efforts.

The success of the projects of the OBU rely ultimately on its Members and I thank every Member who has attended our events or made a contribution to either the School or the OBU. In particular I thank the Members who are present at the AGM.

It goes without saying that none of this would have been possible if not for the generous sponsors who have readily come forward to support our projects and that we appreciate patronage.

Last but not least I thank all the Members of the Executive Committee who have worked as an efficient team in carrying out the heavy workload which we carried out this past year.

Next year marks the 80th Anniversary of the School and the 40th Anniversary of the OBU. Our action plan has already been set for us – it is to support the School, in any way and every way, in its unprecedented efforts to modernise the infrastructure of the School.

MEMBERSHIP DEVELOPMENT SUB-COMMITTEE

Co-Chairpersons: Fayyaz Mukthar & Santhosh Jayasinghe

The membership of any association is the very core of its existence and for an association such as the OBU it is imperative that up to date records of the membership are maintained in order to draw on the resources and good will of the membership and to maximize the potential and impact of the projects of the OBU. Towards achieving this end the Executive Committee of 2016/2017 re-appointed the sub-committee to address the issue of Membership Development.

The membership database handed down to the present Executive Committee was incomplete in many ways with the details of Members being either incomplete or inaccurate. There were also a vast number of pending applications which needed to be processed from a considerable period of time.

Therefore, the sub committee undertook the process of data cleansing (double checking names, membership numbers, addresses, email addresses, telephone no's etc.), updating the information of existing members, clearing the backlog of pending applications in an organised manner and expeditiously processing current applications for membership in order to improve and update the accuracy of the membership database. The sub-committee also recommended to the Executive Committee that the plastic membership card be made mandatory for all members, in place of the existing card.

The sub-committee has managed to implement the above strategies successfully with a significant quantity of temporary membership cards to new Members and new plastic membership cards to existing Members being issued thus far, clearing the backlog to a great extent. Furthermore, the membership database is continuously updated with information from members. However, there still remains a fairly large number of incomplete records.

A software program developed for the database has greatly assisted the work of the sub-committee. The Executive Committee has also authorized the sub-committee to enlist additional manpower and employ ICT based solutions, in particular social media, to further develop the membership database and the application process. The sub-committee is confident that the work of the sub-committee could be streamlined and strengthened with these strategies in place.

The sub-committee realizes that delays may have been experienced by some in processing their membership application forms and thank them for their patience in this regard, as it is a manual, time consuming process done on an honorary basis.

The sub-committee places on record it thanks to the vital assistance from the School administration and staff, without whose enthusiasm and unstitled cooperation and support these vast strides could not have been made in such a short time.

The Membership of the OBU currently stands at 2153 and 36 new Members were enrolled in the past year (the names of new members have been included in the Annexure to the Report).

WEB & IT SUB-COMMITTEE

The following events were conducted by the Web & IT sub-committee during the year:

- i. Worked with Headmaster and School staff to finalise the content for the new website for the School. Awaiting finalisation from the School to go live;
- ii. Created a web application for the OBU database for the Membership Development sub-committee to use. This is in data cleaning stage now;
- iii. Did updates for the web-site of the OBU prepobu.lk> and the newly launched official OBU Facebook group.

The future plans of the sub-committee include modifications to the web-site of the OBU which will include:

- i. Management of the OBU website through a Content Management System (CMS), so that each sub-committee can take the responsibility of updating the news on their own work; and
- ii. Integrating a form for members to be able to update their details online to facilitate the work of the Membership Development sub-committee to keep the database up to date

LEGAL & CONSTITUTIONAL AFFAIRS SUB-COMMITTEE

At the first meeting of the Executive Committee it was decided to create a new sub-committee called the Legal and Constitutional Affairs Sub-Committee to continue the work of the sub-committee that was looking into matters relating to the "S. Thomas Preparatory School Old Boys' Union Trust Fund" (OBU Trust Fund) and also to study and propose amendments to the Constitution of the OBU.

a. S. Thomas' Preparatory School Old Boys' Union Trust Fund

The sub-committee has made the following recommendations with regard to the OBU Trust Fund:

- i.) that the Headmaster nominate two Trustees to fill the vacancies created by the resignations of Mr. Kavinda Dias Abeysinghe and Mr. Manindra Wickremesinghe;
- ii.) that in any event, in terms of the Deed of the OBU Trust Fund the Headmaster, the Honorary Secretary and Honorary Treasurer had the power to act;

- iii.) that the Trust Fund monies should be maintained separately from the general funds of the OBU and should be placed in suitable interest bearing accounts or investments;
- iv.) that the audit reports of the OBU Trust Fund be tabled before the Executive Committee.

Subsequent to these recommendation being made the Trustees took steps to invest the money that was in a Current Account at Commercial Bank in a Fixed Deposit at National Development Bank (NDB)

At present the OBU Trust Fund monies are held in a sum of approximately Rupees 3 million in Fixed Deposits with Nations Trust Bank PLC and a sum of approximately Rupees 3.5 million in investments at Birst Capital Treasuries PLC.

b. Constitution of S. Thomas Preparatory School Old Boys' Union

As several amendments had been effected to the Constitution of the Old Boys' Union at the past few Annual General Meetings it was decided to empower the subcommittee to look into any further amendments that were required. Although a discussion paper was circulated to the Executive Committee and a decision was taken to convene a special meeting to discuss the same such a meeting could not be called due to the constraints of time in view of the activities undertaken by the Executive Committee in the past year.

However, the sub-committee has proposed one amendment to the Constitution which has been placed for adoption at the Annual General Meeting.

SPORTS AND EXTRA CURRICULAR EVENTS SUB-COMMITTEE

The Headmaster has been keen to develop sports and extra curricular activities at the School, even with the limited infrastructure facilities that exist at the school premises and the sports and extra-curricular activities sub-committee has assisted his efforts wherever possible.

The School still lack the space and infrastructure to conduct conventional sports such as cricket, rugby, and football etc. and much of the resources of the School are spent on hiring venues. The Headmaster has been exploring the possibility of getting a ground for the conventional sports and is in the process of discussions with the Ministry of Education.

At present our focus and attention should be on on the support staff and coaches as that School has many young talented students who need the help of professional coaches.

Keeping with the vision of the Headmaster the members of the sub-committee are looking at various sports activities which could be accommodated at the school premises like volleyball, rifle shooting, basketball, badminton and squash.

With the appointment of the Sports Coordinator and Prefect of Games, Mr. Jayamana Perera, we are planning to have a fully equipped sports room for all sports.

We look forward to raising funds to develop the sport and extracurricular activities at School with the support of the old boys and well-wishers. Although an appeal was made earlier for funds to develop sports at the School the response so far has been very poor.

We appreciate all who contributed towards the development of the swimming pool project the "Baby Elephant Bath" which the school ventured into as a result a further reduction in the land as a consequence of the expansion of the Marine Drive. We look forward to more old boys getting involved in this project.

INFRASTRUCTURE AND FACULTY DEVELOPMENT SUB-COMMITTEE

The OBU has been working in close consultation with the Headmaster on infrastructure development of the School. The main focus of these efforts has been to draw up a master plan for the school, which could be implemented in stages. A member of the Executive Committee, Architect Shamin Jayawickrema, has been instrumental in drawing up the plans and he will make a presentation at the Annual General Meeting.

Furthermore, the project to build the 'Baby Elephant Bath' a swimming pool for the School are being spearheaded by the Vice President of the Executive Committee, Mr. Kesara Serasinghe. The OBU decided to use the funds raised from *Prep Night 2017* for this project. The foundation stone for the pool was laid by His Lordship the Bishop of Colombo, Rt. Rev. Dhiloraj Canagasabey, on the 17th of May, 2017.



PREP WALK 2017



RESOLUTION

In terms of Rule 10 the Rules of the S. Thomas' Preparatory School Old Boys' Union shall be amended as follows:-

- 1) The words "at least 21 days before" in Rule 4(c) shall be repealed and replaced by the words "at least seven (7) working days before".
- 2) Rule 5(h) shall be repealed and replaced by the following:

Any Member of the Executive Committee who fails to attend three (3) consecutive meetings of the Executive Committee of which due notice has been given for any reason whatsoever maybe removed as a member of the Executive Committee by a decision of the Executive Committee to that effect. Any Member of the Executive Committee who is removed from the Executive Committee under this provision shall not be eligible for election to the Executive Committee for a period of two (2) years from the date of such removal.
